

Expression of Interest: Maintain your Brain PhD Scholarships

The Departments of Psychiatry and General Practice, within the Melbourne Medical School, are both participating sites in a 5 year duration NH&MRC Dementia Research Team grant led by the University of New South Wales called "Maintain your Brain (MYB)". As part of this collaboration both Departments offer one PhD Scholarship each to commence in 2017. It is expected that both successful applicants would for some components of their PhD projects collaborate with each other.

We are looking for two talented students to undertake a PhD each connected to the MYB study.

Project 1

 of the Academic Unit for Psychiatry of Old Age (AUPOA) research team in the Department of
 Psychiatry.

- Our preference is for a full-time student.

The student will be supported by experienced multidisciplinary supervisors and will become part of the Maintain your Brain (MYB) research team in the Department of General Practice.

- Our preference is for a full-time student.

Project Details

The Maintain your Brain (MYB) study is a large NHMRC funded Dementia Research Team Grant which (2016-2020) led by Professor Henry Brodaty at the University of New South Wales. Professors Jane Gunn and Nicola Lautenschlager are members of the multi-institutional investigator team. MYB is a large internet-based multi-domain intervention study with dementia-free participants living in NSW scheduled to commence May 2017. The intervention lasts for 4 years and the aim is dementia risk reduction.

The two PhD fellowships are part of a Knowledge Transfer Hub (KTH) attached to MYB and based at the University of Melbourne. Other collaborating sites for the KTH are the Australian National University and the University of Western Australia. The aim of the KTH is to develop evidence on how current knowledge about dementia risk reduction strategies is best communicated to general practitioners, other health care providers, the general public and people at increased risk of developing cognitive decline and dementia. The focus for this aim is on Australia, but international evidence and knowledge transfer activities will be investigated. The results of the two PhD fellowships will be of crucial importance to MYB as the will provide the foundation on how to best disseminate the results from MYB once the trial is completed.

These two PhD fellowships offer a unique opportunity to work in a multidisciplinary environment as part of a large multi-institutional study and to contribute crucial new knowledge how to best transfer knowledge on dementia risk reduction strategies from research environments into the Australian community.
